

HIV/AIDS: What's New in Guidelines and Recommendations from the CDC

Several guidelines and recommendations about the prevention, screening, diagnosis, treatment, and management of HIV infection and HIV-related diseases in the United States have been issued by the Centers for Disease Control and Prevention and other federal government agencies. Implementation of guidelines and recommendations should also consider other standards, best practices, regulations, policies, and laws articulated by state and local government jurisdictions, public health authorities, health systems, and public and private sector programs and insurers that provide or cover costs of health services.
